CV Chapter next scheduled rally is GEAR November 9-16, 2025 at Ocean Lakes Campground at Myrtle Beach, SC. CV Chapter has a rally scheduled for August 2026 at Anchor Down RV Resort. Information for Anchor Down is in the Colonial Crier Newsletter.

GEAR Rally Master David Fowler solicited Chapters to place adds in the GEAR 2025 Program. CV BOD (Officers) choose not to spend our Treasury for an add because we don't have much information (rally schedules) to advertise.

West Tiffin Voyagers National Director Report

Family RV Association Governing Board Meeting

Wednesday, 16 July, 2025, Gillette, Wyoming

I attended the annual FRVA Governing Board meeting held during the 111<sup>th</sup> International Rally in Gillette WY.

There were 154 FRVA chapters represented, and a quorum was established

Standing rules were reviewed and adopted. Treasurer's/Finance Committee report reviewed and accepted.

Standing Committees -

- Constitution and Bylaws. There were 5 proposed Bylaw amendments presented:
  - A Full Life Member (who paid \$1000 years ago) is not entitled to waived FRVA convention fees like the Life Members (past presidents and founders) are.
     PASSED
  - Allow the Immediate Past President who sits on the FRVA Executive Board as an advisor, to have voting rights. NOT PASSED
  - Delete the restriction on FRVA members that also own small RV related business from not being eligible to run for national office. PASSED
  - Allow 2 two-year terms for Executive Board members, even if they filled a portion of another term. PASSED
  - Allow the Commercial Council President to serve as a non-voting advisor to the FRVA Executive Board. PASSED
- Convention

- Perry, GA and Sedalia, MO are the planned convention sites for 2026
- Perry, GA and Gillette, WY are the planned convention sites for 2027. There
  was a later discussion about NOT coming back to Gillette in 2027, and the
  summer 2027 convention location was changed to TBD.
- Policies and Procedures. There were 7 recommended P&P changes presented.
  - Membership Enrollment P&P revised to cover the Pathfinder membership category. PASSED
  - Statement of Investment Policy P&P revised to add cryptocurrency to the list of prohibited assets. PASSED
  - Chapter and Assoc Chapter Applications P&P revised to clarify that family and life members count towards the certified chapter members. PASSED
  - Nomination and Election, Chapter Officers Responsibilities P&P revised to clarify that the chapter Alternate National Director is an optional position.
     RETURNED TO COMMITTEE
  - Chapter National Director and Alternate National Director Responsibilities
     P&P revised to clarify when it is appropriate to appoint a chapter temporary delegate versus electing a temporary delegate. PASSED
  - Area Association Creation and Operation P&P revised to add Dissolution process. PASSED
  - FRVA Review Council Responsibilities P&P revised to cover the procedure of dissolving an FRVA area. RETURNED TO COMMITTEE

Actions for 2024/2025. These items are actions taken by the Executive Board (EB) and Board of Directors (BOD) from Aug 24 thru Jul 25. There were 6 items to be voted on that required approval of the Governing Board (GB).

- Request the GB authorize the sale of two pieces of FRVA owned residential property that are adjacent to the Clough Pike headquarters. These were purchased years ago for possible expansion of the HQ, but are now a yearly financial burden with property taxes and upkeep. PASSED
- Recommend the GB authorize the EB to conduct a study into the feasibility of consolidating the two current FRVA properties at Clough Pike (HQ) and Round Bottom Rd (Campground & Storage bldg.) into a single FRVA facility. PASSED
- That the EB approve a decrease in the Commercial Memberships dues for new and renewal commercial members to \$69 until 16 Jul 2025. PASSED
- To approve the locations of Perry, GA and Sedalia, MO for the 2026 International Conventions. PASSED
- To approve the locations of Perry, GA and Gillette, WY for the 2027 International Conventions. PASSED after the deletion of Gillette WY. Summer 2027 convention location now TBD.
- To recommend GB quorum be amended to: "A quorum for the transaction of business at the GB meeting is 25% of the voting chapters or 75 members from the voting chapters, whichever is less" PASSED

There were 17 GB "Informational items" which had previously been reported/approved in the EB and BOD meeting minutes and were provided to aid the GB in exercising its oversight of ERVA affairs.

- To suspend the "share the love" campaign beginning 17 Aug 2024
- To change the FRVA CEO title back to Executive Director
- To refer the possibility of a Lifetime Membership campaign
- To purchase the FRVA.com domain name
- To move FRVA away from its AMS/IT system
- To allow in house FRVA IT staff to develop proof of concepts for management software modules for membership, events and chapters.
- To start newly updated membership plates (goose eggs) as of 1 Mar, 2025
- To recommend the EB approve the RV Overnights proposal
- To approve the 2025-2026 insurance policies renewals on 01 Apr, 2025
- To suspend the monthly dues option
- To change the affiliate programs both family and chapter to include members who have expired for 60 days or more, not 6 months.
- To earmark 50% of FRVA's net operating earnings to each of the reserve funds in the investment portfolio.
- To set aside \$20K for educational purposes in FRVA's 2026 fiscal year proposed budget

- To accept the Wage Review Board recommendation for the 2026 budget for salaries and contract employee expenses in the amount of \$1,929.926.
- The Constitution and Bylaws Committee, Policy and Procedure Committee and Governance Committee will review governing documents and recommend what items the GB must approve versus what the EB can approve
- To approve the proposed 2026 fiscal year budget with a surplus of \$20,121
- To award the 2025 Robert L. Richter Award to David Meyer, F477215, Dogwood Chapter.


